CONFLICT OF INTEREST

Dr. Preston asked if any Board member had any conflict of interest with any item on the meeting's agenda. There being no conflict, the agenda was approved.

APPROVAL OF MINUTES

The Board approved its minutes of December 11, 2014, as amended.

TREASURER'S REPORT

The Treasurer's Report was reviewed and approved as presented.

ADMINISTRATIVE REPORTS

Mr. Wilkins reported:

New Rules

There are no rules currently at the Rules Review Commission. The Establishment Regulation Rules have been informally reviewed by attorneys at the Rules Review Commission. Changes suggested have been made and are ready for Board approval. Once approved, the rules will be sent to the Office of Administrative Hearings for publication in the NC Register to begin the rules adoption process.

The Joint Legislative Procedure Oversight Committee reviewed the Rules Review Commission report on the final classifications for 21 NCAC 30. The Committee approved the report and the Board is required to readopt Rules .0201 and .0701.

Status of Amendments to Practice Act

There are no amendments to the Practice Act scheduled for consideration. The General Assembly is currently in session.

Disciplinary Hearings

There are three hearings scheduled today at 1:00 p.m. All three hearings have been postponed to the April 23, 2015 Board meeting.

Consent Orders

Mr. Wilkins informed the Board of complaints filed against Sherry Carpenter and Michael Young for allegedly practicing massage and bodywork therapy with an expired license. The Board agreed to consider the proposed Consent Orders in Closed Session.

14,585 have been issued

Renewal Report

There are 4,859 licensees scheduled to renew for the 2015-2016 renewal period. 4,118 therapists have renewed. 3,085 therapists renewed online and 1,033 therapists renewed by mail. 412 Letters of Reprimand were mailed in January 2015 for therapists who renewed between November 2, 2014 and December 31, 2014. The routine Continuing Education Audit letters were mailed February 5, 2015 to 200 therapists who renewed online. The continuing education certificates are due to the Board by March 31, 2015.

Dr. Preston reported the Committee met with Donna Sarvello, VP of Educational Support for NCBTMB, via conference call to discuss NCBTMB's CE approved provider program, the contract with New York State, a potential contract with NCBMBT, NCBTMB's teacher training program and school approval process. The Committee will schedule a future conference call to discuss NCBTMB's school approval process.

OLD BUSINESS

NC General Assembly Proposed Laws Affecting Licensing Boards

Mr. Wilkins reported on proposed laws pending in the North Carolina General Assembly that may affect professional licensing boards. Study recommendations were reported to the Joint Legislative Program Evaluation Committee and the Joint Legislative Administrative Procedure Oversight Committee in December 2014 and January 2015. Mr. Wilkins provided the Board with a copy of the letter to the Program Evaluation Division providing the Board's view of the results of the study. Mr. Wilkins also reported he has been meeting with a group of attorneys who represent various professional licensing boards to respond to the Program Evaluation Division and their study and suggest possible legislation.

2015 Strategic Planning Conference

Dr. Preston reported on the 2015 Strategic Planning Conference held at the Rizzo Conference Center in Chapel Hill, North Carolina, January 30th-31st, 2015.

Upon motion made, seconded and passed, the Board approved Rule .0201 and agreed to complete the rules review process for Rule .0201.

Rule .0701

The Board reviewed the Notice of Text and changes to Rule .0701 pursuant to House Bill 74, requiring re-adoption of rules designated as 'necessary with substantive public interest'. Upon motion made, seconded and passed, the Board approved Rule .0701 and agreed to complete the rules review process for Rule .0701. Ms. Foster recused herself from voting on this agenda item. Since Rule .0701 references Rule .0702, the Board agreed amendments were appropriate for Rule .0702 to conform with amendments to Rule .0701.

Rule .0702

The Board reviewed the Notice of Text and changes to Rule .0702 clarifying continuing education requirements. Upon motion made, seconded and passed, the Board approved Rule .0702 and agreed to complete the rules review process for Rule .0702. Ms. Foster recused herself from voting on this agenda item.

Rules .1001-.1015

The Board reviewed the Notice of Text and addition of Section .1000 to regulate massage and bodywork therapy establishments. Upon motion made, seconded and passed, the Board approved Rules .1001, .1002, .1003, .1004, .1005, .1006, .1007, .1008, .1009, .1010, .1011, .1012, .1013, .1014 and .1015 for adoption and will begin the rules review process.

April Board meeting

The Board discussed changing the April Board meeting from April 16, 2015 to April 23, 2015. There was also discussion of the possibility of also meeting on April 24, 2015 due to pending disciplinary hearings. Upon motion made, seconded and passed, the Board agreed to change the April 16, 2015 Board meeting to April 23, 2015 and to be prepared to continue the meeting on April 24, 2015 for disciplinary hearings, if necessary.
