Ms. Foster introduced Ms. Rachael Goolsby to the Board. Due to pending approval of her Statement of Economic Interest, Ms. Goolsby was not sworn in and did not participate at the Board meeting.

CONFLICT OF INTEREST

Ms. Foster asked if any Board member had any conflict of interest with any item on the meeting's agenda. There being no conflict, the agenda was approved.

APPROVAL OF MINUTES

The Board approved its minutes of June 15, 2017.

TREASURER'S REPORT

The Treasurer's Report was reviewed and approved as presented.

ADMINISTRATIVE REPORTS

Rules

There are no rules being considered at the Rules Review Commission.

Status of Amendments to Practice Act

Mr. Wilkins informed the Board Senate Bill 548 passed and was signed by the Governor in July 2017 which gives the Board authority to regulate massage and bodywork therapy establishments. Mr. Wilkins also informed the Board of the plan and timetable to implement licensure of massage and bodywork therapy establishments.

Disciplinary Hearings

Mr. Wilkins informed the Board of pending complaints and proposed Consent Orders regarding: Robert Cooney and Thomas Oakley for engaging in inappropriate sexual contact with a client during a massage and bodywork therapy session; Heather Parker for practicing massage and bodywork therapy with an expired license; David Salih for practicing massage and bodywork therapy without a current license; and Yanqui Shao and Qian Lin for aiding and abetting illegal massage and bodywork therapy practice. There are also two disciplinary hearings scheduled today.

Licensee Report

16,673 have been issued 9,018 active licenses

Renewal Report

There are 4,017 licensees scheduled to renew for the 2018-2019 renewal period. 598 licenses expired December 31, 2015 and can renew by December 31, 2017. Online license renewal information was sent by email in July. The online renewal system is now requiring employment to be entered. There is a box to check if a licensee is not practicing massage and bodywork therapy in NC which allows the licensee to leave the employment section blank. This additional information will assist in identifying and collecting information about massage and bodywork therapy establishments.

COMMITTEE REPORTS

Policy Committee

Ms. Foster reported the Committee met August 16, 2017, and discussed the matters set forth in the minutes of the Committee.

Continuing Education

Ms. Foster reported the Committee discussed the progress of the FSMTB continuing education program and the development of criteria for continuing education. Ms. Foster also informed the Board the Committee reviewed a proposed Letter of Agreement and Contract to be sent to the CEO and Chair of the NCBTMB. Upon motion made, seconded and passed, the Board agreed to send the Letter of Agreement and Contract for approval by NCBTMB.

FSMTB

a. Regulatory Education and Competence Hub (REACH) program

Ms. Foster reported the Committee discussed the REACH program and Ms. Harrell will be meeting with FSMTB regarding development of a treatment planning/intake course in August 2017.

b. Email regarding Massage Therapy Licensing Database (MTLD)

Ms. Foster reported the Committee reviewed the memorandum dated June 30, 2017 from FSMTB regarding MTLD. Upon motion made, seconded and passed, the Board agreed to participate in the database process.

c. 2017 Proposed Resolutions

Ms. Foster reported the Committee reviewed the 2017 proposed Resolutions being discussed at the 2017 FSMTB Annual Meeting. Upon motion made, seconded and passed, the Board agreed Ms. Kirk, FSMTB delegate for the Board, will vote in favor of the three resolutions.

Senate Bill 548 and MT establishments

Ms. Foster reported the Committee discussed Senate Bill 548 and the proposed plan to implement licensure of massage and bodywork therapy establishments.

Senate Bill 407

Ms. Foster reported the Committee discussed Senate Bill 407 regarding the requirements for independent contractors through the Employee Fair Classification Act.

Email from Jena Skai regarding Fascial Stretch Therapy

Ms. Foster reported the Committee reviewed an email dated June 23, 2017 regarding Fascial Stretch Therapy. Upon motion made, seconded and passed the Board agreed Fascial Stretch Therapy is within the scope of practice of massage and bodywork therapy and will be added to the 'List of Modalities Requiring Licensure' on the Board's website.

Email from Delores Harris regarding Stretch Zone

Ms. Foster reported The Committee reviewed an email dated May 30, 2017 regarding the Stretch Zone. Upon motion made, seconded and passed the Board agreed Stretch Zone is within the scope of practice of massage and bodywork therapy and will be added to the 'List of Modalities Requiring Licensure' on the Board's website.

Concerns with English proficiency

Ms. Foster reported the Committee discussed the issue of students graduating from NC Board approved schools without being proficient in the English language. Upon motion made, seconded and passed, the Board agreed to send a notice to all NC Board approved schools and community colleges regarding the requirement of English proficiency in Senate Bill 548.

Art of Healing Privilege License

Mr. Wilkins informed the Board Senate Bill 548 will require massage and bodywork therapists to obtain an Art of Healing privilege license beginning July 1, 2018 from the North Carolina Department of Revenue.

License Standards Committee

Ms. Layden reported the Committee met June 16, 2017, and discussed the matters set forth in the minutes of the Committee.

School Approval Committee

No written report. Mr. Wilkins informed the Board a new school application has been received from Roebuck Institute in Huntersville, NC.
