CONFLICT OF INTEREST

Ms. Turk asked if any Board member had any conflict of interest with any item on the meeting's agenda. There being no conflict, the agenda was approved.

APPROVAL OF MINUTES

The Board approved its minutes of February 17 and 18, 2022.

TREASURER'S REPORT

The Treasurer's Report was reviewed and approved as presented.

ADMINISTRATIVE REPORTS

Rules

There are no pending rules at the Rules Review Commission.

Practice Act

There are no pending amendments to the Practice Act.

Disciplinary Hearings

Mr. Wilkins informed the Board of proposed Consent Orders regarding: Emma Elliott and Michael Nicholson for practicing with an expired license; Jasmine Segarra for practicing prior to being licensed; Betty Foster for injuring a client during a massage and bodywork therapy session; Morgan Peeples for providing massage and bodywork therapy while under the influence of an intoxicating substance and failing a voluntary drug test; and Joseph Goodwin for engaging in inappropriate sexual contact, draping and conversation during several massage sessions.

There is one hearing scheduled for today for Anthony LaValle. The hearing scheduled for PinHui Wang has been postponed to the June meeting.

Licensee Report

20,222 have been issued. 9,421 active licenses.

Renewal Report

There are 4,302 licensees scheduled to renew for the 2022-2023 renewal period. 3,653 therapists have renewed. 3,505 therapists renewed online and 148 therapists renewed by mail. The routine Continuing Education Audit has started for 200 therapists who renewed online.

Establishment Report

968 establishments have requested an application.444 establishments have submitted an application.177 establishment licenses have been issued.

Ms. Kirk reported the online profile for establishments is ready to be posted on the Board's website. An email will be sent to all licensed establishments once access to the profile is on the website.

COMMITTEE REPORTS

Policy Committee

Ms. Turk reported the Committee met April 20, 2022 and discussed the matters set forth in the minutes of the Committee.

FSMTB

a. Massage Therapy Licensing Database (MTLD) program

The Committee reviewed updated information regarding the MTLD program and recommended that Board staff and IT set up a virtual meeting with DEG to review the database process in the Board office. The Board agreed with the Committee's recommendation.

b. REACH course for establishment owners

The Committee discussed requesting FSMTB to develop a course for establishment owners and agreed to continue discussion on this topic at a future committee meeting. The Board agreed with the Committee's recommendation.

c. Email from Debra Persinger regarding surveys

The Committee reviewed an email dated April 11, 2022 from Debra Persinger regarding notifying NC LMBTs to participate in a survey for the licensing exam. The Committee agreed for the Communications Committee to discuss this information and draft an email to send to NC LMBTs. The Board agreed with the Committee's recommendation.

Anthony LaValle

Ms. Turk reported the Board reviewed the evidence presented during Mr. LaValle's hearing and was of the opinion Mr. LaValle failed to deliver treatment that ensured the client's safety, comfort and privacy and failed to get informed consent from the client during a massage and bodywork therapy session. Ms. Turk reported the Board Ordered that Mr. LaValle be required to complete nine (9) continuing education hours in communications, roles, boundaries and ethics and pay a civil penalty of \$250 and disciplinary costs of \$500.

Ms. Turk reported the Board will respond in writing regarding the establishment regulation and sole practitioner issues expressed by AMTA NC-Chapter.
